

INVITATION FOR BIDS

Sealed tenders are invited till 10-08-2016 at 1400 for the supply of:

Package: 1 furniture, fixture.

Package: 2 security and IT equipment.

for ADP scheme namely "Establishment of Centre for Survivors of Violence against Women at Multan (VAWC) of the Department of Social Welfare & Bait-UI-Maal from well reputed manufacturers, sole agents, contractors registered with Income Tax Department and Sales Tax Department. The detail and specifications of items are mentioned in the tender form.

TERMS AND CONDITIONS.

- 1 The tender for each package with detail of items comprising terms and conditions can be purchased during office hours except holidays till one day before the tender opening date, from Directorate General Social Welfare & Bait-UI-Maal,41-Empress Road, Lahore with a cost of Rs.1000/- (Non Refundable).
- 2 No tender form will be issued by dak or telegram.
- 3 Bid security equal to 2% of the bid money in the name of Director General Social Welfare and Bait-ul-Maal Punjab, Lahore in shape of call deposit along with copies of the registration / renewal certificate from Income Tax and Sales Tax Department, technical specifications of items should be accompanied with each tender form. The tenderer should bring the original registration / renewal certificates for verification by the Procuring Agency.
- 4 Sealed tenders must be submitted in the office of Director General, Social Welfare and Bait-ul-Maal Lahore till 1400 on 10-08-2016, which will be opened on the same day at 1430 in the presence of bidders or their authorized representatives who intend to be present at the occasion.
5. The rates per item should be quoted both in figure and words.

- 6 The procurement under reference shall be conducted in accordance with PPRA. 38 (a) 2014 (single stage two envelop) procedures. The bidder must submit an affidavit on legal paper confirming that the firm/agency has not been black listed by any Govt. / Authority and is not involved in litigation against any Govt. / Autonomous Body.
- 7 The conditional and the status so claimed has take intact till the finalization of the bids and without bid security tenders will not be entertained.
- 8 The Procuring Agency can reject all tenders at any stage prior to the acceptance of a bid or proposal.
- 9 The bidders would be required to quote price of each item in the package failure to which the bid being non responsive shall straight away be rejected. The evaluation of the bid shall be made on package accumulative cost basis.
