1. The appointment will be made on contract basis initially for a period of **One Year**, which may be extended as per rules / policy / recruitment.

3. Applicants currently employed in Government Service must apply through proper channel and attach a NOC from their parent department.
4. Only complete applications received before the deadline through courier will be considered for further processing. Applications submitted by hand will not be considered.
5. Only short listed candidates will be called for test and interview.
6. Candidates called for test / interview shall not be entitled for any TA/DA.
7. Age relaxation as per Government policy has already been included in the age limit mentioned against each post.
