1. Punjab Bait ul Maal, Council, invites electronic bids on e-procurement system, e-Pak Acquisition Disposal System (EPADS) at www.punjab.eprocure.gov.pk from the eligible bidders for the Procurement of Assistive Devices for Persons with Disabilities (PWDs):

The electronic bid must be accompanied by scanned Bid Security 02% of total estimated cost amounting to Rs. 400,000 in the form of CDR/ bankers cheque / bank guarantee from any scheduled bank in favor of the Deputy Administrator Bait ul Maal Punjab, Lahore. The original instrument of Bid Security must be delivered at the Office of the Secretary, Punjab Bait ul Maal Council 41 Empress Road Lahore prior to closing date of submission of bids. The relevant branch of bank (from where the bid security is being issued for bidder) should also send the scanned copy at the following e-mail address: asbm.pbmc@gmail.com
4. Single Stage – Two Envelopes bidding procedure shall be applied as per rule 38(2) (a) of Punjab Procurement Rules, 2014.
5. The complete electronic bids must be submitted online at www.punjab.eprocure.gov.pk, as per following schedule:

6. All prospective bidders shall be required to quote rate of each/every item in the Lot. Any item mentioned without quoting the rate shall make the bid non-responsive. The lowest evaluated bidder shall be determined on the cumulative quoted rate of entire LOT.

NOTE: The procurement shall be conducted as per Punjab Procurement Authority Act-2009/PPRA Rules, 2014.
